To Kee or Not to Kee...That Is the Question!

Following a discussion of the members of the Dreamland Villa Board, it was decided to request that all members of Dreamland Villa carry their kee cards. Each room in the DV facilities has a sign in sheet and all members are to enter their individual name and card number on that sheet. Do not leave doors unlocked or ajar for entry. Remember, every resident in a DV home needs to have and use their own individual card to enter and enjoy use of Common Areas. Monitors for various activities will be asked to make sure that attendees have signed in and have current cards.

The DV "Common Area Rules and

Regulations" state: 1. Only members and their guests are permitted use of Corporation facilities, with the exception of those facilities open to the public. 2. Use of kee card controlled Corporation facilities is restricted to members and their guests. 3. Guests will be allowed use of Corporation facilities provided they are accompanied and signed in by the host member. 4. A guest who resides in the general area of but outside Dreamland Villa and who is accompanied by a member will be allowed use of the Corporation facilities for the day of his/her visit. It is not intended that such guests will be permitted unrestricted use of

Corporation facilities and such guests will limit such use to no more than twice in any given calendar month, regardless of whose guest he or she is. It is the host member's responsibility to ensure that their guests do not violate this rule.

For those households who have chosen to forgo paying their dues, I suggest you read the article written in this issue by Charles Dubbs. Membership funds that help keep the amenities of DV in good order and the quality of your neighborhood attractive have a big impact on the future of Dreamland Villa. Remember the bottom line on this is "There is no such thing as a "free lunch"!"

Residential Rental Registration and Classification Change Is in Effect

Addendum Notice -received with your tax bill

In accordance with House Bill 2221 enacted in the 2006 legislative session, the purpose of this addendum is to inform property owners of the following: If the property listed on this Notice of Value is used for rental residential purposes as defined in A.R.S. §42-12004 and is currently classified as legal class 3 (primary residence), you must register the property as rental residence (legal class 4) with the County Assessor pursuant to A.R.S. §33-1902 of the Rental Residential Property law. Failure to do so may subject you to a penalty. If the property is leased to a qualifying family member the property must be registered with the County Assessor pursuant to A.R.S. §33-1902 but it will still qualify as a class 3 property.

In order to register your property, you may visit our website at: http://vwww.maricopa.gov/Assessor/Residential_Property_Form.aspx

If you fail to register the rental property with the County Assessor after receipt of this Notice of Value, the city or town in which the property is located may impose a civil penalty in the amount of one hundred and fifty dollars (\$150) per day payable to the city or town for each day of violation, and the city or town may impose enhanced inspection and enforcement measures on the property.

Note: Several Arizona cities and towns impose a transactional privilege (sales) tax on persons engaged in the business of leasing or renting residential property. You can access the Model City Tax Code Section 445 for information on the cities and towns that

impose the tax to determine if you are required to report the rental use. The web site for the model city tax code is www.modelcitytaxcode.org. That site also contains a phone number to answer questions you have regarding the applicable requirements for the municipal privilege/sales tax program. Residential Rental Properties are required to comply with the Landlord Tenant Act pursuant to Title 33, Chapters 10 & 11.

Citizen Book Review

52 Loaves: A Half-Baked Adventure

by William Alexander

When he returned from a European vacation, William Alexander came home to New England with a mission. At a Paris restaurant, he had eaten the "perfect loaf" of peasant bread and he vowed to re-create it. So, each Sunday morning for a year he made a round loaf of peasant bread in an attempt to get it right.

52 Loaves is the story of his quest for this perfect loaf. The book is divided into 52 chapters, one for each week of the year. Each chapter addresses a particular issue. Alexander has a reputation as an essayist and humorist, and this book is a fun read. Several chapters explore the adventure he undertakes in growing, harvesting and grinding his own wheat. Another time he goes to Maine to a conference and learns about making an outdoor wood fired oven. Later, he actually builds his own oven in his large back yard. He finds a nearby bakery that uses a huge wood fired oven and transports one of his loaves to them to bake.

Many chapters in *52 Loaves* take on an educational tone. When Mr. Alexander decides to undertake the making of his own levian (sourdough starter) the nature of yeast is explored and explained. His levian goes with him everywhere, on vacation to Maine, and to France. The scene at the airport when he tries to explain why he is boarding with this mass of what looks like plastic explosives is hysterical. The historical changes in flour, the milling processes and the differences between our flour and the flour he finds in France are explained. He also researches the early 20th century disease pellagra and its relationship to the changes in diet in the south.

Researching his peasant loaf had lead Alexander to study baking in ancient monasteries. He eventually found a still active monastery with a wood fired oven. The oven had not been used in decades and the monks reluctantly allowed him to bring their oven back to life if he would teach them to bake their own bread again. A week-long baking course at the Ritz in Paris is followed by a brief side trip to Morocco where he frantically looks for a village oven. He returned to Paris on the eve of a nationwide rail strike and barely made his connections to pick up his levian and clothes on his way to the monastery in Normandy. After some repairs to their old oven and cleaning up the kitchen, he continues his research with the monastery oven. The Monks are very appreciative of his efforts and put their old oven into daily use and even exchange e-mails with him.

Alexander's physician wife and teenage children enter into the dialog in the book, sometimes in a humorous way, other times grudgingly. His wife makes comments about their white bread diet and the kids routinely ask for croissants. This wonderful memoir is fun to read and makes me want to go out and find William Alexander's other book, *The \$64 Tomato*.

What Happens to a Complaint?

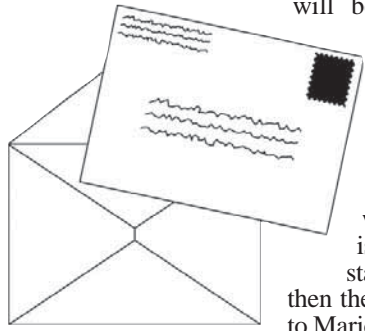
Once again we want to remind our members that complaints must be in writing in order for the Complaint Committee to pursue. When we receive a complaint from a member, we review the property to be sure the complaint is in violation of Maricopa County Rules.

If the complaint is a violation and the person who files the complaint is a member and the person who the complaint is against is also a member, a Courtesy Letter will be sent giving a 10-Day notice for compliance. If the property owner does not bring the property into compliance, the complaint is filed with Maricopa County. If the person against whom a complaint is filed is not a member in good standing of Dreamland Villa, then the complaint is sent directly to Maricopa County who then may issue a violation notice and access

finer up to \$150.00 per day.

A person filing a complaint who is not a member in good standing of Dreamland Villa, is not entitled to the services of the Complaint Committee. They will need to file their complaint directly with Maricopa County Enforcement.

Properties that are found to have underage persons without a qualifying occupant are sent directly to Maricopa County Enforcement. We believe strongly in enforcement of the "Senior Overlay."

(The above procedures are result of a resolution adopted by the Board of Directors, November 8, 2011 relative to working under the Non-Profit Statues rather than the Planned Community Statues.)

We are moving closer to the season when our winter residents begin to think of heading "home" and many of our activities begin to slow down. One thing that doesn't change between our seasons is the need for all of us to be constantly vigilante in the maintenance of our homes. Please, if you are leaving soon, arrange for someone to care for your property. Remember to give us an emergency contact number when you complete the form for the Sheriff's Posse to check your home in your absence. When completed Sharon, the office secretary, will notify the Sheriff's Posse, and remember to let the office know when you have returned.

Let's all work to be good citizens of Dreamland Villa Community Club. Please remember that your Membership Card "Kee Card" is required for entry into the public areas as well as required for participation in the many activities. 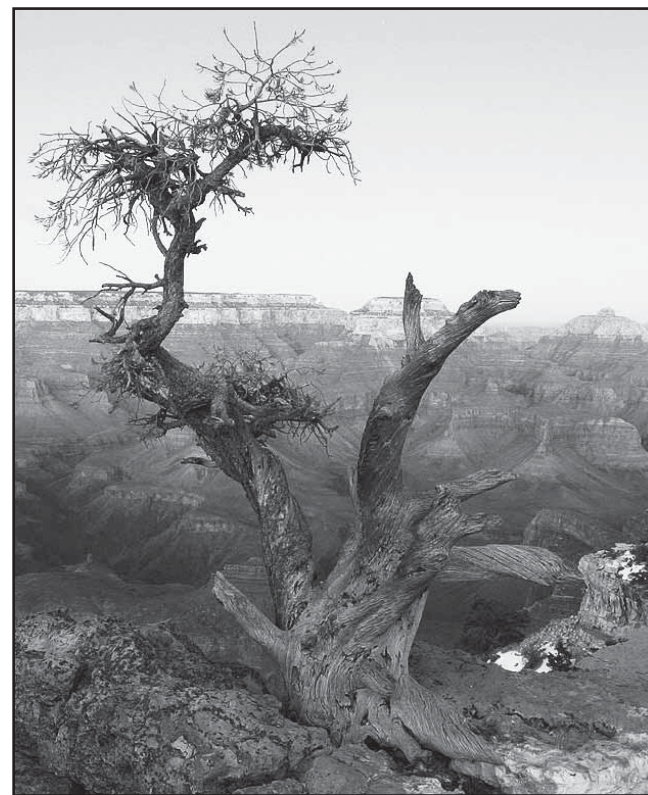

Entertainment. Dorothy Randall reports many activities this month including potluck dinner, pancake breakfast and talent show. Check the Citizen and the website for details.

Library. Agnes Forsyth reports 652 books checked out in February. A new History Buff corner has been created. Need summer volunteers – work one-half day week only. Report on file.

Hobbies, Crafts, Indoor Activities. Lyle Wood reports

Outdoor Recreation Activities. Ralph Shirey reports warmer weather has brought out more people enjoying activities. Shade near pickle ball courts is under construction. Swap Meet will be 3/31 at Farnsworth. Rent a space for \$10 and optional, rent a table for \$5. Report on file

Contract Committee. Lyle Wood has no report.

Kitchen Committee. Judy Ford thanked volunteers. George Sheppard will be back as Kitchen Manager. More volunteers are always needed.

Nature Walk. Mr. Westall reports that he will set a clean-up day in April. Volunteers needed.

Welcoming Committee. Charles reports for Hazel Dubbs. Report on file. 17 residents attended the March orientation. Next orientation will be May 10th.

Strategic Planning Committee. Everett Boyd not present. No report. Scheduled for April Study Session.

Website Committee. Dorothy Randall encourages use of DVCC website. She continues trying to make things easier for resident users.

Old Business Discussion:

By-Laws Change: Composition of Bd. Of Directors. Jim Cook explained different options were pursued and changes need to be made to Article VI, Section 1, new language is as follows: **"The Board shall consist of the number of members as provided for in Article XI, Section 4, below. The term of each**

Board member shall be for three (3) years, except for any member elected to complete the unexpired term of a vacant Board position."

Article XI, Section 4 is proposed to read as follows: **"Beginning in 2013 and each year thereafter, four (4) directors shall be elected each February for a full three (3) year term each. The four directors receiving the most number of votes shall serve a full term of three (3) years. Candidates receiving the next highest number of votes shall fill any two-year vacancies on the Board and the candidates receiving the next highest number of votes shall fill any one-year vacancies on the Board. In case**

of a tie vote, a flip of a coin shall determine the winner. A director that has served two consecutive terms, not to exceed a total of six (6) years, shall not be eligible for reelection to the Board until there is a lapse of at least one year following the last term served."

Jim Cook made a Motion to accept the above changes. Motion passed.

A/C for Computer Room as Capital Expense. Steve Holleque made a motion to replace said air conditioning unit. Motion passed.

Shuffleboard Resurfacing as Capital Expense. A bid from Floor Care of Arizona was accepted. Steve Holleque made a motion to go ahead with repairs. Motion passed.

Retrofit Lighting with Rebate. Larry Wilkens reports an audit of our lighting has been accomplished. It is recommended that all light bulbs be replaced with high efficiency bulbs. Checking with SRP to see what rebate will be offered. Further report at next meeting.

New Business Discussion:

By-Laws Change: Audit. Jim Cook explained the Board felt that a CPA audit was not necessary every year but only every five years or when the Board decided on a need for such. The new wording to Article VI, Section 4 of the DVCC By-Laws is as follows: **"The Board of Directors shall engage, every five (5) years, commencing in 2015, a Certified Public Accountant to perform an audit and review of the Club's financial records and procedures. The Board of Directors, during the intervening years, shall appoint, at the beginning of each fiscal year, a committee of three (3) qualified voting members in good standing to perform the audit and review of the Club's financial records and procedures. All audit reports shall be completed no later than one hundred and eighty (180) days following the end of the corporation's fiscal year and shall be made available, upon request, to the members within thirty (30) days of the audit's completion."**

Mr. Cook made a motion to accept the above wording. Motion passed.

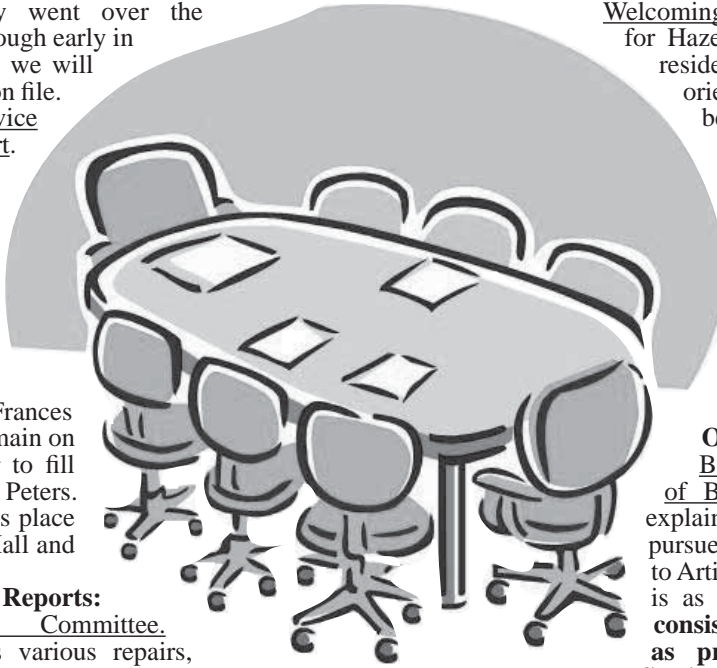
Audit Report. Dennis Zurbay was not in attendance. Mr. Cook made a motion to accept the Audit Report. Motion passed.

Dreamland Villa Community Club Board of Directors Study Session Meeting Minutes

March 6, 2012

President Westall called the meeting to order at approximately 9:20 AM. Board members present: Jim Cook, Judy Ford, Agnes Forsyth, Doris Gruner, Steve Holleque, Lyle Wood, Frances Skaggs, Patricia Thorpe, Gerald Westall, Larry Wilkens, Gloria Wilson-White and Gordon Watson. Excused: Linda Roujon. Unexcused: Steve Peters. Also present: Charles Dubbs, Administrative Services Manager.

Audit Committee Report – Dennis Zurbay discussed the audit report recently completed by the Audit Committee. The audit report will be placed on the March Board meeting agenda for acceptance by the Board. It was pointed out that while the Board must formally accept the audit report, doing so does not mean the Board accepts or rejects any of the recommendations contained in it. Acceptance of any recommendations must be the result of specific Board action.

The stipulation in the By-Laws that the annual audit be conducted by a Certified Public Account was brought up for discussion. It was decided that the By-Laws Committee will prepare a modification to Article VI, Section 4 changing the requirement for a CPA to conduct the audit every year to every so many years, the frequency to be determined by the By-Laws Committee.

Changing the Composition of the Board of Directors – Jim Cook presented the By-Laws Committee recommendations regarding the reduction in the Board composition. A copy of the review and the committee's recommendations are attached to the office copy of these minutes. The committee's recommended modifications to the By-Laws will be placed on the agenda for the Board's March meeting for adoption.

Excessive Absence of a Director – Lyle Wood brought up the issue of a director who has an excessive number of unexcused absences from Board meetings and asked that the item be placed on the Board's March meeting agenda. In that this issue could result in disciplinary action against a Board

member it must be discussed in executive session. The President will call for an executive session of the Board following the regular March Board meeting.

Retrofit Lighting with Rebate – Larry Wilkens reported that he and Steve Holleque conducted an audit with G & A Services Electrical Contractors of all lighting fixtures in all DVCC buildings. G & A submitted the results of the audit along with their recommendations of what lighting fixtures needed to be upgraded to SRP. SRP's response regarding the submission and possible rebates is due back by next week. There are approximately 3,000 bulbs involved. The program would not only replace the bulbs but also sockets, ballasts, etc. G & H's projected guess is that DVCC's share of the cost will be approximately \$3,000.00 after the SRP rebate. This item is to be placed on the Board's March meeting agenda.

Shuffle Board Request – Steve Holleque discussed the Floor Care of Arizona proposals to refurbish three shuffleboard courts. Bruce VanVleet reviewed the condition of all eight shuffleboard courts. The proposal to refurbish three shuffleboard courts using the poly diamond system for \$3,750.00 will be placed on the March Board meeting agenda. The cost of the project, if approved, will come out of the Equipment Replacement/Improvement Fund.

Strategic Planning Committee Suggestions – Lyle Wood brought up the recommendations presented last December by the Strategic Planning Committee. Much discussion ensued particularly about improvements at Farnsworth Hall. Mr. Wood suggested that perhaps the approach to the committee's recommendations should be on a "what we can afford" basis. Patricia Thorpe suggested the issue be placed on the Board's April Study Session agenda for more discussion. In the meantime, Mr. Wood will get more information on the cost to purchase an electric sign.

Card Usage/Facility Usage by Non-Members – Lyle Wood brought up the issue of people who are not paid members of DVCC using the Club's facilities and

attending activities. At a previous meeting, it was agreed that the people in charge of



the various activities should be responsible to ensure only members and qualified guests attend each activity. The problems with this approach and the issue in general was discussed at length. It was concluded that a letter should be sent to the leader of each activity reiterating the Club's policy on attendance. It was further recommended that the President should discuss the issue in his monthly article in the *Citizen*. Additionally, a luncheon meeting should be held with the leaders of each of the activities, minimally twice a year, to discuss various issues. The issue will not be placed on the March Board meeting agenda.

Escrow Response Form – As information to the Board Charles, Dubbs reviewed the process used for informing new and prospective homeowners in Dreamland Villa of the Club's membership requirements and associated fees particularly relating to the changes made in the Membership Card Issuance Definitions, the Escrow Response Form and the Membership Agreement. Mr. Dubbs stated the changes made are an attempt to satisfy the problems the office has been having with homeowners, real estate agents and title agencies. Mr. Dubbs also emphasized the need for Board members to fully understand the issue of admission and transfer fees.

Read Hall Foyer – Charles Dubbs brought the need to clean up the foyer (street entrance) to Read Hall. It was agreed that this was an issue that should just be addressed by the office and the Maintenance Department and did not require Board action.

Renting of Two Halls – Charles Dubbs said he placed this item on the agenda because of concern in the office that there are rental categories where no rent is charged. Particular concern is that the Club still has expenses such as setup and teardown costs, utility costs, and etc., for which the Club is not being reimbursed. The issue was referred to the Policy and Procedures Committee for review and recommendations.

Jam Session for 2012-2013 Season at Farnsworth – Patricia Thorpe brought up the issue of the Jam Session, the potluck dinner and the pancake breakfasts all occurring during the same week of the month and asked if these events could be spread out over more weeks during the month. Judy Ford said they had already had discussions with the Jam Session group. Ms. Thorpe will look at the possibility of moving the potluck dinner to the fourth Thursday of the month.

New Equipment at Farnsworth Hall – Steve Holleque announced that a new projection screen and digital projector have been installed at Farnsworth Hall. Mr. Holleque said that Harry Cole was concerned about the use of this and other equipment by hall renters and suggested that our rental policy be modified to include a requirement that only DVCC approved and qualified individuals be allowed to operate the lighting and audio/visual equipment. This issue will also be reviewed by the Policy and Procedure Committee.

A/C for Computer Room as Capital Expense – It was agreed that the Computer Room air conditioner needs to be replaced. The item will be placed on the agenda for the March Board Meeting.

Adjournment:

Last Potluck of the Season to Be Held

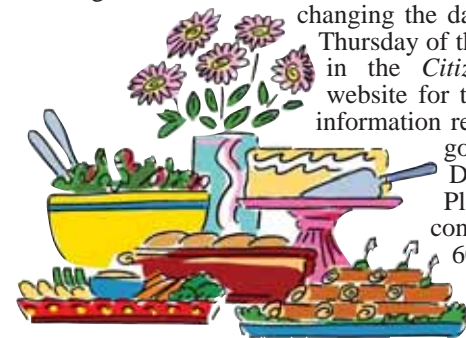

History of Pickleball

After playing golf one Saturday during the summer of 1965, Joel Pritchard, congressman from Washington State and Bill Bell, successful businessman, returned to Pritchard's home on Bainbridge Island, Washington, to find their families sitting around with nothing to do. The property had an old badminton court so Pritchard and Bell looked for some badminton equipment and could not find a full set of rackets. They improvised, cutting shafts of the damaged rackets and found a perforated plastic ball. The rackets didn't work very well, so the dads created four wood paddles, similar to today's wood paddles. At first they placed the net at badminton height of 60 inches and volleyed the ball over the net. As the weekend progressed, the players found that the ball bounced well on the asphalt surface and soon the net was lowered to 36 inches. The following weekend, Barney McCallum was



introduced to the game at Pritchard's home. Soon, the three men created rules, relying heavily on badminton. They kept in mind the original purpose which was to provide a game that the whole family could play together. The Pritchards had a cocker spaniel named Pickles who became interested in this new game. Whenever a ball would come his way, he would take the ball and run off with it, because you see, it was Pickle's ball. And that is how the game got its name. Copied from the USAPA website
