In addition to the obvious facilities such as the pools and sport courts, the club's office maintains all the records for and files all the reports to the proper government agencies to maintain the 55 overlay. This process is much more expensive than most believe.

We provide the facilities for members to enjoy activities like cards, lapidary, ceramics, billiards, exercise, room, pickleball, bocce

ball, shuffleboard, computer room, woodshop room, art club, library, nature walk, swimming, hot tubs, state clubs etc., etc. Members pay for all of this, non-members do not.

Please encourage your neighbors to join the club. Our members are the best source for new members. However, if you bring your neighbors and friends to any of the functions that are not open to the public, then you are not helping yourself or the club. While it may seem harmless and have no obvious expense involved in letting a non-member play cards, shuffleboard, attend a state club meeting, there is an expense. That expense is in the form of non-payment of dues by that individual. Allowing a non-member to use your membership card or into

an activity is a form of stealing from the dues paying members. THIS INCLUDES LETTING YOUR SPOUSE USE YOUR CARD IF YOU ONLY PAID FOR ONE PERSON'S DUES.

If you know some who is participating or using the facilities and is a non-member, encourage them to join. If you feel uncomfortable asking a non-member to leave, contact the office. Someone else will talk with them.

Be aware that the club soon will be checking for membership cards at the pools and activities. Someone may come in and ask everyone in the room or pool to show their cards. Please don't get angry with them, show them some respect. They are only protecting your interests.

On November 11th all persons living in our Dreamland community were invited to attend a special informational meeting at Farnsworth Hall. An afternoon and evening meeting gave persons who are employed the opportunity to be included. Approximately 800 persons were in attendance at the meetings.

The presentation reported the fact that we have reached a critical time. Our current income is no longer adequate to continue operations of our facilities. If you missed the meeting and wish to see documents that were handed out you will find them on the Dreamland web site at dreamlandvilla.org

On November 18th a second meeting was held at Farnsworth Hall at 2:00 PM. This meeting was for current Dreamland Villa Club Members. The sole purpose of the meeting was to vote on the membership dues for 2015. A motion was made and seconded to increase the annual dues to \$175 per person for 2015. Following discussion and call for the vote, 473 persons turned in ballots. The motion passed with 425 yes and 48 no votes.

We hope we have made residents aware of exactly what it takes to keep our community strong and our home values up.

Silent Seasons by Gillian Hart

Join Racine as she is forced at the age of only sixteen into a marriage to an older man she had never met. The story begins in 1848 in London and Racine has already turned down three of the prospective bridegrooms that her father has suggested. Against her father's wishes, her mother has allowed Racine to educate herself far beyond the usual finishing school subjects. Racine is a very independent young lady, but she is given no choice this time. She must marry Clive Morehouse.

After the hurried wedding, Racine is just about finished decorating her new home when it is announced by her father that she and her husband Clive are to move to New York City. Racine already knows her husband is not a very nice man, and when she over hears Clive and her father discussing how much he is being paid to haul her to the other side of the Atlantic, she loses any remaining respect she had for either of them.

So many things happen so quickly when they arrive in New York. Racine meets and becomes friends with the wife of an associate of Clive's. Racine and Clive buy a home and acquire servants who quickly become loyal to Racine rather than the ill-tempered Clive. Clive begins to harass Racine about beginning a family and he blames her for the lack of children.

This is a fast paced story and hard to put down. Within the book there are lovers and movers and shakers and heartbreak. In the end, the family dynasty has helped push the growing railroad to the uninhabited west. A talented child has established herself as a jewelry designer and the world has changed very much. During the past year we have been bombarded with articles in the *Citizen* about the potential loss of the senior (55+) overlay zoning, seen facilities closed for the summer, and swimming pools closed for many days. Why? Declining revenue from dues.

To address this issue, I propose that the Board change its focus by adopting a *Marketing* philosophy, for the purpose of increasing the number of paid memberships. I have written a "Strategic Plan" to achieve this goal.

Nearly 500 members stopped paying dues in the last two years. Why? What can we do to re-engage them? Increasing the number of residents who pay dues would allow 2016 dues to be lowered AND facilities to be kept open year round.

The Board should inform realtors and title companies about the May 2014 changes to the Dreamland Villa Community Club's (DVCC) fees and dues. The Board should also make sure that real estate listings of DV homes disclose the senior (55+) overlay and that DV is a retirement community.

The Board's actions should focus on adding value to DVCC membership. When the Board addresses the interests of its customer base (DV residents), revenue from dues should increase.

Background: I was raised on a small farm in upstate New York, moving to Arizona initially in 1960. In 1980, as a single parent, I returned to Arizona with my two sons, who continue to live in the area. In 2007 I moved to Dreamland Villa because of the *Pride of Ownership* displayed by our community.

Every so often someone will donate a piece of medical or health care equipment to Help Services that, for one reason or another, we have determined is not practical to carry in our loan equipment inventory. An example would be a powered scooter. It's not that we aren't grateful for the donation. We are grateful for all donations. We either are not in a position to maintain an inventory of certain types of equipment or the demand just isn't there. So, we clean and repair each such item and then make it available to the residents of Dreamland Villa and Velda Rose Estates for a fraction of what it would cost new.

We recently received such a donation. It is a pair of e-motion power assist wheels for a wheel chair. New these wheels would cost in the vicinity of \$6,000. Information provided by the manufacturer states the e-motion features the only power assist on the market powered by long lasting Lithium-Ion technology for 3x more range. The Ergonomic Control System customizes the e-motion to the user's needs. Rollback delay prevents the chair from rolling back while climbing inclines. There are 2 power levels, a battery capacity indicator, 10 programmable parameters, and self-diagnosis for easy trouble shooting. The wheels are very easy to dismantle making the chair ideal for transportation.

Only the wheels were donated to us. To use them it will be necessary to purchase a wheel chair frame. The wheels will not fit on just any wheel chair frame, therefore, it is unlikely an individual that could use these wheels would not have a wheel chair frame that they would fit on. The wheels and wheel chair frames are sold locally by Southwest Medical.

Our service person has gone over the wheels very carefully and feels they are in excellent condition. Because this is not the type of item we could use in our loan equipment inventory we will make them available for a donation

of \$50. If you are interested or for more information, please call Bob Blalock at our office/warehouse facility at (480) 985-6021 or drop in at 5210 E. University Drive. We are open from 9:00 AM to noon, Monday through Saturday.

We have been mentioning these wheels for several months. If there is no interest shown in the next thirty days, they will be given to another charity organization.

Where have the months gone? They just fly by, don't they? By the time that you read this both Thanksgiving and Christmas will have been here and gone. I just can't believe it. I want to remind you of all of the things that we have for you to borrow whenever you need them. We have things like wheelchairs, (long arms, short arm, reclining), all kinds of walkers, commodes, bath benches, hospital beds, over the bed tables, shower seats, toilet seat risers, (some with handles and or rails), crutches, canes, quad canes, folding canes, baby beds, high chairs, baby strollers, and even some toys for when you have your grandchildren come to visit. We also have a wet/dry vacuum, in case you have an accident at your house and need to get rid of all that water quickly. Most know that we have roll-away beds for when you have company. If you don't know all about this, just do come in and visit to see what all is in our warehouse. You probably would be surprised.

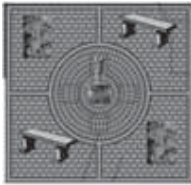
Dreamland Villa Memory Brick Project Update

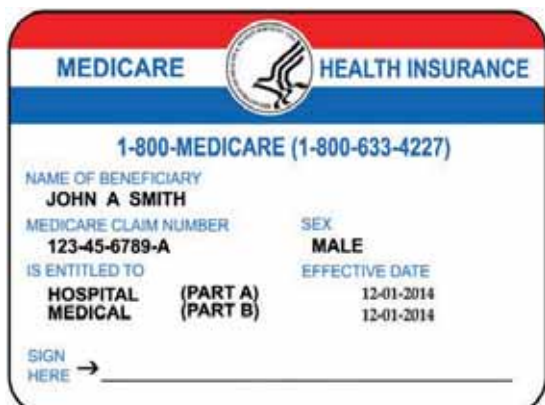



Old Business:

Place Hot Tub Covers on hold. Lane Allen expressed how he would like to take the hot tub covers off of the expense list. The purchase of hot tub covers was approved by the Board April 2014. It was explained to the Board that an anonymous donor would give DVCC \$10,000 to buy a pool cover for Farnsworth Hall if DVCC would keep the pool open year round. Mr. Allen would like the monies approved going to the hot tub covers and use it towards any extra money needed for a pool cover at Farnsworth Hall. Enforcement of Kee Cards. Reviewed the By-law regarding membership and households and that every person in a household must buy a membership card. Discussion followed.

New Business

Windows for Read Hall. Red Westall presented a report on earnings of the Duncan Street Rummage Sale Project. After collecting \$1,048.00 and DVCC contribution of \$812.19, the Club was able to replace the following windows: 4 at the restrooms at Farnsworth pool and windows on order are 3 for Read Hall; 1 for restaurant (John's Villa) and 1 for the green room next to Read Hall as these windows get the most sun from the south, for a total cost of \$1860.19. Jim Cook reminded the Board that all monies donated to DVCC is not Tax Deductible; and that the Board needs to be sure to include that information to all those who donate monies toward DVCC. 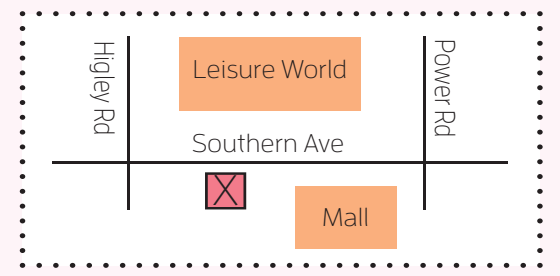
