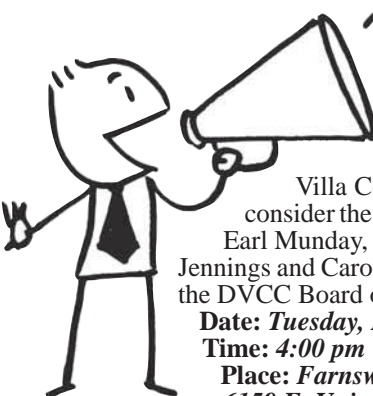


Wounded Warrior Project.

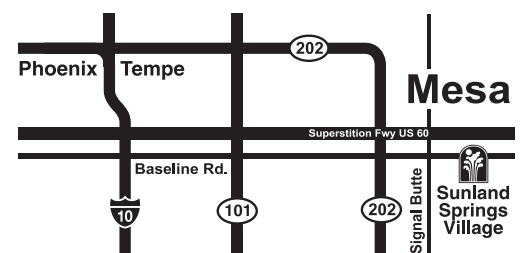

Dance of the Bones

by J.A. Jance

Spanning more than forty years and the 1600 miles between Tucson and Seattle, "Dance of the Bones," the latest in the Brandon Walker family series, is an intense story. J.P. Beaumont plays a small part in the story and it is always good to see him again. Each chapter is headed with a short piece of Tohono O'odham or Papago Indian lore.

When Amos Warren's decayed body was discovered in the desert many years after his disappearance, his business partner and protégé, Big Bad John Lassiter, was arrested. He went to prison for life firmly declaring his innocence. John had not seen Amos since the night they had an argument in a bar over John's girlfriend, Ava Martin. Soon after Amos disappeared, Ava dumped John and he had developed a drinking problem. Shortly before his arrest, he had turned his life around with a new girlfriend.

During the thirty years he had spent in prison, John had educated himself by reading through the Encyclopedia Britannica. He had unfortunately developed MS and was wheelchair bound. A group called TLC (The Last Chance), made up of retired policemen from various parts of the country, became involved in John's case. They wanted to get him out for time served by pleading guilty to manslaughter, but John would not accept this as he was not guilty. About the time TLC is getting involved, John's daughter whom he has not previously met shows up on the scene. She has been looking for her father because she has MS and wanted to know more about her family history. John does not want to be a burden to her, which is another reason he thinks it might be more advantageous for him to stay in prison.

Moving in and around this main mystery is Brandon Walker's family involvement in a current local crime wave. Unfortunately, more lives are taken. Ava Martin, whose involvement in this more current crime wave was uncovered, is taken down.

All of these stories, the old crime, the more recent crimes and the Indian stories, mesh together into a complex but very readable story.

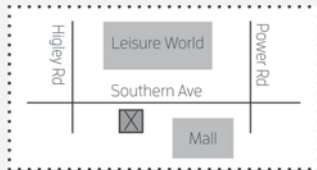

Application for a DVCC Bingo License: Another Viewpoint

At the public meeting in November of 2014 it was mentioned that if revenue fell off too far for DVCC then we might have to cut expenses. One way (among others) that this could be done would be to close the Farnsworth facilities. A couple of DVCC members (non-Board members) were very concerned about this possibility. One of them offered to paint the surrounding fence, with free labor, and to design a new sign and new electronic billboard to improve the appearance of the facility and draw more participation to events and fundraisers at Farnsworth. Another offered to try to reestablish bingo, with all profits to go towards supporting Farnsworth. In order to do this he asked for help from two Board members.

These three individuals and four DVCC members (two Board members and two non-Board members) filled out the application for a bingo license to the best of their ability. Funds were placed in a bingo bank account, as required by the license application. The county approved the application and

forwarded it to the state (who had final approval authority). The state ultimately sent a letter indicating that the license would be put on hold until corrections in the application were made. That letter was published in the October *Citizen*.

When polled via email, seven of the directors indicated they would vote to approve bingo, four did not respond. In August a letter was received from a lawyer by the seven DVCC members who filled out affidavits for the bingo application. The letter indicated that the lawyer represented DVCC and made several demands related to stopping the bingo process. As a direct result of that letter, the primary applicants for the license withdrew the application and closed the bank account. In addition the applicants withdrew their commitment to guaranteeing the bingo pots.

Bingo at DVCC is now a dead issue, as I know of no one willing to submit an amended application, no one willing to volunteer to handle the games, and no outside funding source is available.

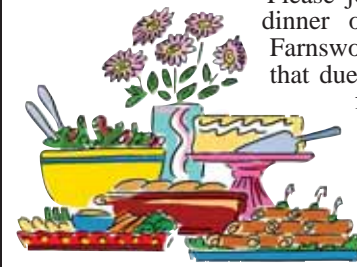

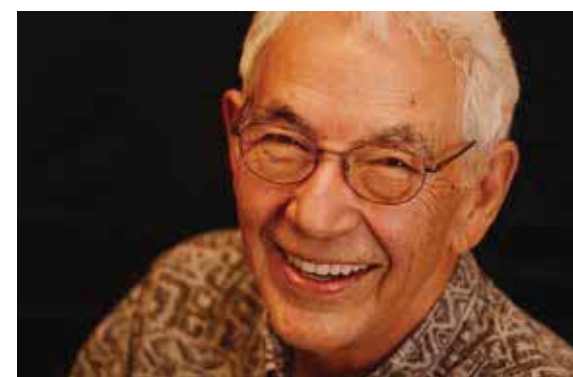
And Bernie? Not only does he embrace the company of others, he also takes advantage of every mirror he sees, shooting himself a dazzling smile.
