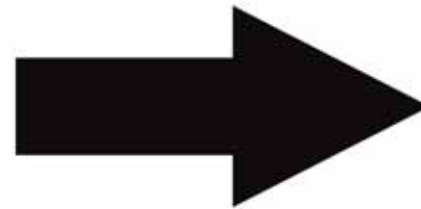
it was not intentional. Please accept my apology. We will do better next time.

Do you want to be a part of the community that makes Dreamland Villa a great place to live? Do you want to live in an environment with quiet streets and low crime? Did you really think you could buy into a 55+ community with amenities and not pay for any of it? Be part of the solution. Make a difference and pay your annual fee. It is a small price to pay (less than \$15 per month) to keep our quiet and pristine neighborhoods the way they are. And, this year we implemented a payment for those of you unable to pay the fee all at once.

Another note, I personally am tired of hearing the stories of people that don't pay their annual fee because of some issue they had years ago. Get over it. You're using that as an excuse

to withhold your funds from our community. You may be saving yourself a few dollars by not paying, but you are hurting our community. Our annual fees pay to maintain our 55+ status, provide office and maintenance staff, maintain our buildings and pools, and provide our residents with a library, an exercise room, a nature walk, pool tables, a woodshop, and many other recreational activities and classes. These are the amenities that you agreed to support when you purchased your home in DVRC. Whether you partake of any of our amenities or not, it is your obligation to provide your financial support.

And for those realtors out there that think you are making it easier to sell a home in Dreamland by not mentioning the transfer fee and saying the annual fee is optional, you are wrong. Anyone interested in living in a 55+ community knows that there are fees involved. You are doing your seller and purchaser a disservice, and you are hurting our community. ## Election of Directors for Dreamland Villa's Board of Directors

The 2018 Election for Directors will be held at Read Hall from 8 a.m. to 7 p.m. on Tuesday, February 13, 2018. Voters need to present their 2018 Membership Card in order to cast their vote. Clear directions will be given to each voter when they register to vote. Note: Those unable to vote on Election Day should go to the Dreamland Villa Business Office to obtain and complete an absentee ballot PRIOR to Election Day.

Read Hall and the DVCC Business address is 320 N. 55<sup>th</sup> Place, Mesa, AZ.

House-bound members may request an absentee ballot by calling the Dreamland Villa Business Office at 480-832-3461. Then, the Board of Directors shall arrange for an absentee ballot to be taken to the house-bound member's residence.

The four candidates, for the seven vacant seats, are: Kathie Chismar, Donna L. May, Mary Newkirk, and Johna Sharp. The top three candidates with the most votes will take the three-year terms. The next candidate will take a two-year term. If there is a tie, it will be settled by a coin flip. Once the directors are seated, additional directors may be appointed to fill the remaining vacancies.

### KATHIE CHISMAR

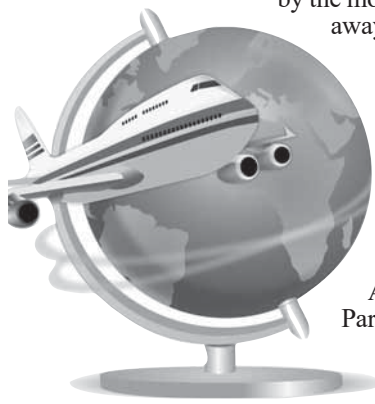

# The Posse Corner

I hope that by the time you read this, you will have received our annual request for donations. It's through your donations that we can maintain the Posse Operations here in Dreamland Villa. Your generosity is used to purchase, update and maintain our equipment. We also pay for the insurances for our vehicles and equipment, which is not cheap. This year we have to replace one of the vehicles, as the maintenance costs have made it cost prohibitive to continue using. Not a penny of your donations gets used to purchase uniforms or personal equipment, as that cost is entirely borne by the posse members themselves.

In 2017, we logged over 3,000 hours of patrolling and training. We also performed close to 4,000 house checks for our residents who were away. In addition, we've performed many details for the Maricopa County Sheriff's Office. Details such as traffic control at the scene of accidents, maintaining the security of crime scenes, security and traffic control at parades, "Shop with a Sheriff", Mall Patrols during the Christmas season, and many others. We do this with eight people.

Next year we hope to entice more members to join us, but as you can imagine the sales pitch needs work. "Come join our group, no pay, but you can put your life in danger,

buy your own uniforms and equipment, (sometimes over a thousand dollars), deal with unsavory characters, and spend many hours away from your families." It's no wonder that only a few people, dedicated to helping their community and making a difference in the "valley" step forward to do the job. Please help to keep us safe and operational. Thank you.

# Dreamland Villa Retirement Community, Inc. Annual Membership Meeting

January 9, 2018, 2 p.m. Farnsworth Hall

**Welcome:** Johna Sharp, President

**Pledge of allegiance**

**Call to Order:** 2:03 p.m. by Johna Sharp, President

**Quorum:** There were at least 130 members present, satisfying the quorum of 100 members.

**Introduction of Current Board Members:** Johna Sharp introduced herself, along with the current board: Bruce Gile, Mary Newkirk, Ward Jennings and Donna May

**Treasurer's Report:** Ward Jennings presented the 2017-year end treasurer's report, showing that DVRC ended the year in the most favorable condition since 2011. A Capital Expenditure Budget for 2018, as drafted by the Building and Grounds Committee, was presented. These reports may be found with these minutes on the Dreamland Villa website.

**Explanation of proposed By-Law Changes:** There were three proposed changes to the DVRC By-Laws:

**Article X, Rules, Section 3:** All members of the Dreamland

Villa Retirement Community shall be required to show their current membership cards when attending business meetings, elections, and other official function of the Club for identification except where public attendance is permitted (add: *by the Board of Directors*) Page 4 of the website's By-Laws

**This voting occurred by a show of hands, 120 "yes"; 10 "no". This change was approved.**

**Article XII, Membership and Dues, Section 5:** New members shall pay 1/12th, to the nearest whole dollar, of the current annual fees for each month, including any partial month, remains to the end of the current year. There shall be no refund of annual fees paid should a membership, for any reason, be terminated. For purposed of this Section, a new member shall be defined as an individual who has not been a member of Dreamland Villa Retirement Community during the ~~past two previous membership years~~ *to be changed to previous membership year.* Page 6 of the website's By Laws. **This voting occurred by a show of hands,**

**120 "yes"; 10 "no". This change was approved.**

**Article XII Membership and Dues, Section 7:** Dreamland Villa Retirement Community memberships not renewed ~~within ninety days of the due date to be changed to~~ *by January 31st of the current membership year* shall be deactivated. Page 6 and 7 of the website's By-Laws. **This voting occurred by a show of hands, 126 "yes"; 4 "no". This change was approved.**

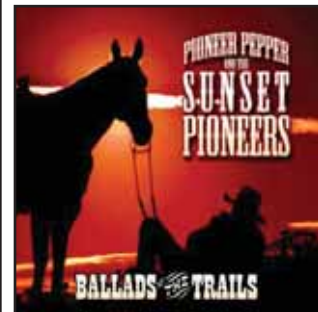
