NATURE TRAIL

Last month the rains started and so did the stinknet; from now until it buds is the time to get rid of it. It can be killed with roundup or by your professional sprayer in your yard. Pulling it out or cutting it off below the surface will destroy it, when cutting off the body of the weed (weedeater) it may come back.

To help clean up the trash that is along the trail, we are asking for volunteers to come on the 4th Saturday of each month (not organized) and help with pickup. We are asking anyone who lives along the trail to please put their garbage can out by the trail. This will give people on the trail who pick up any trash a place to put it. From 9:00 am to 10:00 am volunteers will be on the trail. They will have large garbage bags for you if there is debris that you can pick up for your own garbage can. What we do not want is having the trash cans that are on the trail jammed full of brush.

If you want to remove brush from the trail that is fine, but the nature trail account can't afford to pay any dump charges. Remember to be courteous, and pick up after your dog so everyone can enjoy the DLV trail that belongs to all DLV residents.

How to Become a Sponsored Associate Member

On January 20th, 2024, the Dreamland Villa members approved a motion to authorize the formation of a new class of membership known as Sponsored Associate Members. The purpose of creating this class of membership is to provide for those who live outside of our community to become members and enjoy the amenities and activities Dreamland Villa provides.

These members must be sponsored by an individual voting member (a person who lives in Dreamland and has paid their annual dues is a voting member) and they may sponsor a relative, friend, or co-worker living outside of Dreamland to become a member.

This form of membership has limitations. They must pay the annual fee, they are not able to vote on any of the management functions, and they must be at least 55 years of age. They are not allowed to bring guests to any amenity or activity of Dreamland Villa other than those that authorize outside residents to attend by paying a non-member additional fee for the cost of the event. They must follow all the rules and regulations of the organization.

Should you have a friend, relative, or coworker you would like to sponsor as a member of Dreamland Villa, there is an application form available on the website dreamlandvilla.org or in the office. The application must be completed by both the sponsor and the applicant requesting a Sponsored Associate Membership. Once received, the Board of Directors will review the application and determine if membership should be granted. Should the sponsor move from Dreamland Villa, the Sponsored Associate Member would need to find a new sponsor.

It is the responsibility of the sponsor to ensure that their candidate is an individual who will work to improve our community and maintain our facilities. Each year there will be a limit of 50 individuals who may receive a Sponsored Associate Membership.


BOOK CLUB



"If You See Something, Say MLAND VILLY Something'



Enhancing Counter - Terrorism Awareness - In an era where vigilance is paramount for community safety, the adage "If you see something, say something" has become more crucial than ever. This phrase serves as a reminder of our collective responsibility to remain vigilant and report any suspicious activities that could potentially prevent a catastrophe. The smallest details can be vital indicators of a potential threat, and situational awareness is our first line of defense.

Recognizing the significance of

seemingly inconspicuous details is imperative. Unattended backpacks in crowded places, vehicles lingering near sensitive locations, or individuals taking photographs of buildings or parking areas may be more than mere coincidences. These seemingly innocuous actions could be subtle signs of someone preparing for an event that threatens our safety.

One of the key elements of maintaining counter-terrorism awareness is understanding the importance of reporting such observations promptly. If something appears out of place or raises concern, reporting it to the appropriate authorities can make a crucial difference. It is a preemptive measure that can prevent potential disasters and save lives.

Consider situations where people are carrying unusually large bags that might conceal weapons. Reporting such instances might seem trivial, but it is better to act on suspicion and let the authorities investigate. It's a small price to pay for the safety of our communities.

Moreover, the focus should not solely be on major public spaces. Even seemingly mundane places like schools can be vulnerable, with parked vehicles lingering for extended periods without clear reasons. These could be signs that require attention and reporting.

Fostering a culture of awareness and reporting is a shared responsibility. It is better to report and let authorities assess the situation than to regret not speaking up after an incident. By remaining vigilant and promptly reporting suspicious activities, we contribute to a safer and more secure environment for everyone.

If you see suspicious activity, report it to law enforcement and describe specifically what you observed, including:

Who or what you saw;

When you saw it;

Where it occurred; and

Why it's suspicious.



are 5:00 pm to 8:00 pm.




