Poker Run Fun Will Be April 11

What is a poker fun run? For those who have never participated in one, it's simple, it's fun, and the best part is that you don't need to know how to play poker to win. At the completion of your Fun Run your poker hand value chart will help you, so you don't have to be a poker player to win and have fun.

There will be prizes for the best hands, but most of all you will be supporting our Dreamland Villa Community Club. Whatever way you decide to come, bring friends and neighbors because anyone can participate. Yes, you can go thru more than one time after paying a new entrance fee. You can go thru anytime as long as you start no later than noon. We want all participants to have fun and remain safe. **Remember** speed has nothing to do with who wins, so we need to obey all traffic laws.

Citizen Book Review

Nightshade by Susan Wittig Albert

Susan Wittig Albert is the author of a series featuring China Bayles, owner of a shop selling herbs and other herb based goods called Thyme and Seasons. *Nightshade* is the 17^{th} book in this series, and the third in a trilogy within this series about solving the mystery of the death of China's estranged father. The other two in this trilogy are *Bleeding Hearts* and *Spanish Dagger*. You might wish to read them first!

In *Nightshade*, China, her husband, McQuaid, and China's half brother, Miles Danforth, are in the last stages of the quest to unravel the mystery of the life and death of China and Miles' father, Robert Bayles. Robert Bayles had lived a double life. His alcoholic wife and daughter, China, had taken second place to his secretary/mistress, Laura Danforth and son, Miles. Miles became aware that his "Uncle Bob" was actually his father after the death of his mother and sought out China's help in discovering what actually had happened when his father had died sixteen years previously.

When Miles came asking for help, China was not moved to help him, but McQuaid, her PI husband was very interested and agreed to help, much to China's dismay. She was still angry with her father for his abandonment. Miles' mother, Laura had been conducting her own investigation but several years before her death had abruptly quit working on it. When Miles came upon her notes after his mother's death, he resumed the investigation and asked for help. Besides their father's death, there were several other deaths that Laura Danforth had been looking into and seemed to link together.

Miles sudden death, very similar to the hit and run death of a reporter who had been linked to the death of his father brought China whole heartedly into the investigation. She was executor of his estate and had to make sure his ten-yearold daughter was taken care of as her mother had died a few years previously. Many references to Texas and national

Easy Cooking

Lady Finger Cake

2 packages sugar free Instant Vanilla Pudding

- $3\frac{1}{2}$ cups of cold milk (divided)
- 1 8 oz. Container sugar free low fat Cool Whip
- 1 ¹/₂ boxes of graham crackers
- 1 can of sugar free chocolate frosting

Place whole squares of graham crackers in bottom of a 9 x 13 pan (metal or glass). Set aside. Mix the two packages of sugar free Instant Vanilla Pudding in two separate bowls, using 1 ³/₄ cups of milk for each box of pudding. Add Cool Whip to the pudding and blend. Pour one-half of pudding over graham crackers. Then add the second layer of graham crackers. Cover the second layer of graham crackers with the remaining pudding. Make a third layer of graham crackers. Whip chocolate frosting; if thick add a little milk until it is the right consistency to spread easily over the pudding. Refrigerate until ready to serve.

You can make this dessert with 2 packages of sugar free Instant Chocolate Pudding rather than the Vanilla Pudding.

Dear Club Members,

We have reviewed the accompanying balance sheet of Dreamland Villa Community Club as of December 31, 2014, and the related statement of revenue and expenses for the year then ended, on the cash basis for income tax purposes. A review includes primarily applying analytical procedures to management's financial data and making inquiries of company management. A review is substantially less in scope from an audit, the objective of which is the expression of an opinion regarding the financial statements as a whole. Accordingly, we do not express such an opinion.

The management is responsible for the preparation and fair presentation of the financial statements.

Our responsibility is to conduct the review in accordance with Statements on Standards for Accounting and Review Services issued by the American Institute of Certified Public Accountants. Those standards require us to perform procedures to obtain limited assurance that there are no material modifications that should be made to the financial statements. We believe that the results of our procedures provide a reasonable basis for our report.

Based on our review, we are not aware of any material modifications that should be made to the accompanying financial statements.

3. Reconciled payroll service records to Operating Statement amounts reported.

4. Reviewed activity in all balance sheet accounts with the exception of Petty Cash

5. Sampled two months of credit card charges for proper substantiation and approval

6. Reviewed Board Minutes for Board approval of authorized check signers and authorization of other than ordinary operating disbursements

7. Reviewed disbursements to determine requirements to issue IRS Form 1099's

8. Reviewed copy of filed 2013 Federal Tax Return

9. Reviewed Capital Projects Expense detail for charges that should be classified as Capital Purchases and capitalized on the Balance Sheet.

10. Reviewed January 2015 checks issued for large disbursements that pertain to year 2014.

COMMENTS/NOTES

The books and records continue to be in good order and easy to review. Our compliments again to the office staff.

The accounting for revenue earned as dues was switched to the cash basis as of the end of the 2013 year. Dues are considered earned when received. Therefore dues received in December 2014 as payments for 2015 membership in the amount of \$90,300 are included in the Annual Assessment income amount of \$309,248.79. Dues paid in December 2013 for 2014 membership in the amount of \$87,824.20 were included in 2013 Annual Assessment Income. To restate the year 2014 Assessment Income to compare to years prior to 2013 one would add the deposits received in 2013 for 2014, \$87,824.20 and subtract the deposits received in 2014 for 2015 dues, \$90,300.00.

Annual Assessment Income 2014 + Deposits received 2013 for 2014 - Deposits received 2014 for 2015

\$309,248.79 87,824.20 (90,300.00)

Annual Assessment Income 2014 (old method) \$306,772.99 Starting with year 2013 Depreciation is being booked. This is a non cash expense which means the net cash produced by Net Income will be greater by the amount of the Depreciation.

In last years audit/review comments we addressed the need for a policy and procedure regarding what should be capitalized and depreciated. Our recommendations were to set a dollar limit where capital expenditures above that amount would be capitalized in the Fixed Assets on the Balance Sheet. We would recommend an amount equal or exceeding \$1,000. In our review of maintenance and supply accounts we identified and proposed capitalization of the following items: new pool heater \$2,638, new windows \$1,446, and sidewalk improvement \$3989. These items were added to remaining undepreciated amounts and an annual depreciation charge was calculated and booked. We recommend 20 years straight line on the building roof, seven years on old assets and swimming pool equipment such as heaters and three years on Defibrillators. We would like to see an accounting policy and procedure created encompassing these recommendations which would give guidance to financial and clerical staff.

We are aware various clubs and activities in Dreamland Villa Community Club handle their own finances, including maintaining checking accounts. We did not consider it within our scope to identify or review these activities. However we would recommend the board identify which clubs and activities handle monies, have bank accounts, and what responsibility the club has for these clubs and activities.
