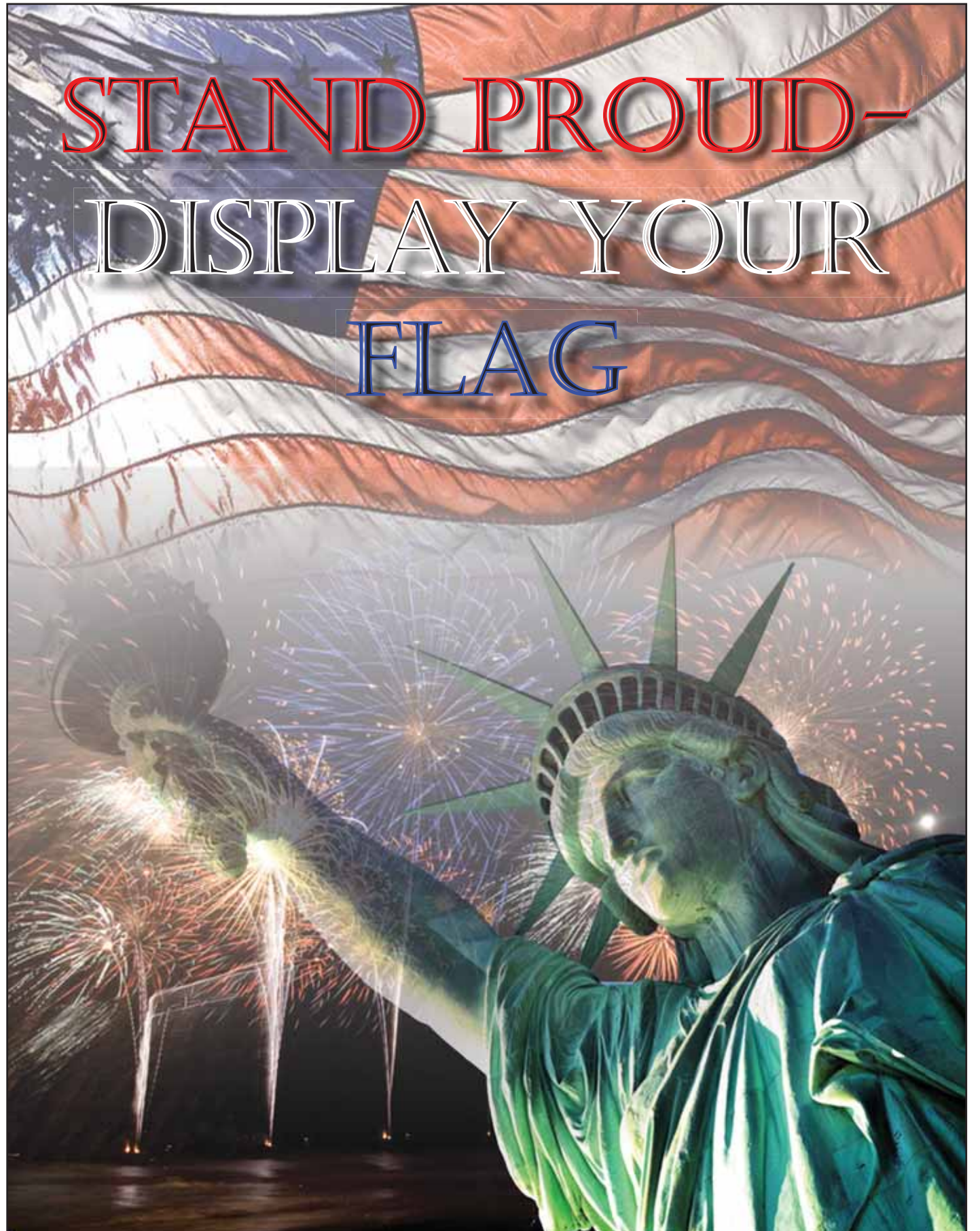

During this process, it became very clear to me that the Dreamland Villa office had outdated office equipment, computers, computer software and telephone system.

An opportunity arose to replace the four-year-old black and white copier with a much newer color copier loaded with more technology and the monthly lease payment is lower! The office can now scan multiple pages and create pdf files which may be sent out as attachments to emails. The color copies may be made after an authorized user logs in. The number of colored copies can be monitored and charged to

On November 30, 2015, I was elected President of Dreamland Villa Community Club's (DVCC) Board of Directors and was re-elected to that position again on March 31, 2016. Since serving as President, Ward Jennings, DVCC's Secretary/Treasurer and I have sent out more than 350 letters to realtors and brokers, realtor associations, title company escrow officers and Dreamland Villa Subdivision residents.

the appropriate committee or club.

The office has four computers, two of which were outdated. A 2007 version of Office Suites' Home and Student had been loaded and used for some time. The outdated computers were upgraded and Office 365, Version 2016, was loaded.

The Windows 10 Operating System was loaded while it is still free of charge. However, we learned that the accounting system DVCC uses, PROMAS, is not yet compatible with Windows 10. We are watching this closely. If we are not able to get a version of PROMAS to work with Windows 10 before August 1, we estimate it will cost as much as \$1,600 to buy Windows 10 at a later date.

Our new Compliance Committee Chairman, Bruce Gile, suggested it would be worthwhile to get a dedicated telephone line so that Dreamland Villa residents could call in and have a verbal complaint recorded and later processed. We then discovered that the existing telephone system was so obsolete that there are no longer service or replacement parts for it and its voicemail features no longer work. CenturyLink provides both the telephone and internet service to the office. CenturyLink has not been able to offer a voicemail solution. The Directors have authorized a new telephone system that provides the voicemail solutions we were seeking.

I am pleased to state Dreamland Villa now has office technology that is years ahead of where it was a few months ago.

A Word from our New Board Member

As a new DVCC member and an even newer Director, I wanted to convey some thoughts of my experience so far. Keep in mind I don't know the history of DVCC. That could be an advantage or a detriment. History can be important in the decision making process, but it can also be an impediment in the advancement of the issues at hand. So, while I can't speak to any of that, I can speak to what I have been a part of to date.

DVCC is run by volunteers, with

the exception of the office staff and maintenance personnel. I have attended Study Sessions, Board and committee meetings and have addressed countless emails. Why? To ensure DVCC continues to exist and thrive as a 55+ Age-Restricted Retirement Community. It is important to me that what we are doing makes sense and is in the best interests of DVCC.

It's o.k. to question the decisions made by the Board of Directors, but I have found there are good reasons why some of the decisions have been made.

While everyone may not agree with all of the decisions, rest assured that the decisions were made with what the Directors thought best for DVCC with the information available at that time. If this was not the case, I would cease to be a member and a Director.

At this point, I am of the mind that not knowing any history is an advantage for me. I can only see what is ahead for DVCC and find ways to move forward. I feel if we don't find new and innovative ways to move forward, then DVCC may soon be "history."

Change

As Dreamland Villa Community Club has grown older, it has faced change. Over half of the Subdivision's homes are now owned by a single person, not a couple. About 22% of the homes are now rentals, not owner-occupied, and a substantially larger number of homes have one or more owners who work.

At the end of 2011, Dreamland's "Club" had 3,694 members and \$400,000 in cash. The Arizona Courts revoked Amendment Two to the Declaration of Restrictions, rescinding Dreamland's status as an H.O.A. Dreamland continued to present itself as a "Club," managing its real and personal property and providing the retirement community's activities and events as set forth in its 1961 Articles of Incorporation. The result, since 2011 the "Club" has had a 44% decline in membership

and a weakened financial position.

A significant change occurred in 1996 when Maricopa County designated Dreamland Villa as a 55+ age-restricted Subdivision. Our records show that each year since December 10, 2001, the Maricopa County Department of Planning and Development has sent Dreamland Villa a letter worded exactly as the one printed below this article.

Paraphrased, Dreamland Villa Community Club, Inc. is the legal entity responsible to maintain the policies, procedures, paperwork and computer systems to identify the owners of the properties in order to annually complete the Verification Statement reporting the percentage of properties with residents who are 55 or older.

As a reminder, if you have not purchased membership in

DVCC, you need to complete the Verification of Occupancy Affidavit mailed to you in March and return it to the DVCC office. If you need another copy of this Affidavit, please call the DVCC office at 480-832-3461.

To recognize the dual legal responsibilities of Dreamland Villa Community Club, Inc., the Directors have changed its marketing message from Dreamland Villa is a "Club" to "The annual fees are essential to keep Dreamland Villa as a 55+ Age-Restricted Retirement Community."

Everyone - current and new residents, realtors and brokers and title company escrow officers should recognize this reality: It is a financially viable Dreamland Villa Community Club, Inc. that keeps the Dreamland Villa Subdivision both a Retirement Community and a 55+ Age-Restricted Subdivision.

Dear Applicant:

As you know, your community is covered under Maricopa County's Senior Citizen (SC) Overlay zoning district. This district requires that at least 80% of the dwellings units be occupied by at least one person 55 years of age or older, and that the community have policies and procedures which demonstrate an intent to provide housing for persons 55 years of age or older.

As indicated in the provisions for the SC Overlay in the Maricopa County Zoning Ordinance, "it is the responsibility of the residents and/or owners of properties (covered by the SC Overlay) to provide evidence that the above criteria are met and will be maintained." To meet the requirements of this provision, we ask that each community with a SC overlay provide an annual Verification Statement to us.

I am forwarding, a copy of the Verification Statement to you, which needs to be completed and signed by someone familiar with the community and return to our office as soon as possible, but no later than December 31, 2001. In most cases a representative of the homeowners association would be most appropriate.

First Women

Kate Anderson Brower spent four years covering the Obama presidency for Bloomberg News and also has worked for Fox and CBS. Brower is also the author of the best seller "The Residence," which tells about life inside the White House according to the staff. "First Women" explores the lives of the ten "modern" first ladies spanning the last 45 years.

"First Women" begins with Jackie Kennedy (who was the first to bring the White House beauty, style, glamour and a young family) and goes through the present first lady, Michelle Obama. Not all of these women had young children, and not all of them were glamorous, but they were all vibrant active members of a post-war generation and beyond. When Jackie Kennedy followed Mamie Eisenhower's reign as first lady, a distinctly different first lady began to emerge. "First Women" explores not only their public image as it has changed, but the private lives of these ten women.

The author explores many facets of the lives of the first ladies - how they raised children with the spotlight always nearby, how they related to the staff, to the public and the role they played in their husband's presidency. Many of these ladies had projects they were passionate about and spent many hours improving awareness of various aspects of our lives. Jackie concentrated on arts and remodeling the White House, Lady Bird Johnson focused on beautifying our country with parks and Nancy Regan spotlighted drug awareness. Betty Ford educated us about breast cancer and addiction to alcohol and painkillers and Michelle Obama has worked to fight childhood obesity. Most of them were also very passionate about being the helpmate that their husband needed to get through the difficult tasks they faced.

The relationships between these women are also explored. Some of them became good friends, some barely tolerated their predecessor or the one who followed them. Most of them were compassionate about the trials and difficulty of living in a glass fishbowl and letters and notes between some of them are very revealing.

The photographs included in the book are wonderful. This is a very well done book and the insight into the first ladies of our modern world is a delight.

The computer room has been closed during May and June. The Maintenance Department has cleaned and

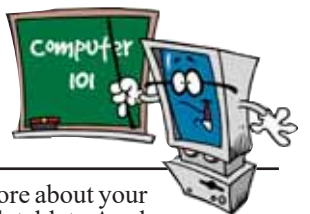

We look forward to having all of our students back in November! We are now allowed to have people who live outside DVCC attend art classes, so we will welcome them back too.



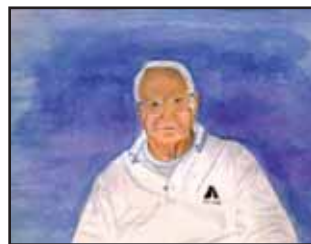

Dreamland Villa Community Club Board of Directors

June 7, 2016, Approved Special Meeting Minutes

The Special Meeting was held pursuant to Section 2, Article I, The President, By Laws, dated January 12, 2016

Welcome: President Carylan McLean

Pledge of Allegiance

Call to Order: 9:00 a.m. by President Carylan McLean

Roll Call: Secretary Ward Jennings

Present: Pat Clark, Bruce Gile, Ward Jennings, Carylan McLean, John Pawloski, Sr. and Janet Peterson

Ratification of Meeting Minutes: Board Meeting May 10, 2016, Minutes ratified.

Treasurer's Report: May 31, 2016, Financial Statements and Treasurer's Report are on file in the office and posted on the official bulletin board. An analysis of the Dreamland Villa Community Club, Inc.'s Financial Statements as of May 31, 2016, reveals the following:

The 2016 revenue from membership and the 55+ fee contributions of \$342,840 exceed the budgeted amount of \$327,250. Further, the revenue through May 31, 2016, is about the same as the calendar year 2015 revenue from membership, less the recall legal expenses.

The Admission Fee (\$400 one-time fee to document the age(s) of residential ownership changes for the 55+ age reporting) is \$10,400 through May 31, 2016, compared to \$12,400 for the entire calendar year 2015. This is a substantial increase in revenue for this line item.

Expenses for the first five months of 2016 are consistent with the budgeted line item expenses.

Conclusion: Dreamland Villa Community Club, Inc. is a financially viable ongoing business, which will allow the Directors to uphold the January 12, 2016, By Laws, Article VI, Section 9, which state: "It shall be the duty of the Board to take care of, control and manage all the assets of the Club, and to maintain the existing facilities in good repair, assigning and reassigning space as needed." The Board will continue to perform the duties as stated in the By Laws.

Old Business:

Parking Lot Resealing and Striping Contract: Bob Westall, Contracts Committee Chairman, reviewed the contract with Epic Asphalt LLC and recommended approval after receipt of an acceptable Certificate of Insurance. Epic Asphalt was lowest of three bids. Bruce Gile moved to approve the contract with Epic Asphalt LLC, dated June 3, 2016, in the amount of \$12,875, for sealing existing cracks, seal and re-striping the parking lots at Farnsworth and Read

Hall campuses. Motion carried unanimously.

Revised Cell Phone Tower Lease: Bob Westall, Contracts Committee Chairman, stated that after reading the DVCC attorney recommended revisions to the contract, he felt confident with going ahead and signing the attorney-revised lease documents. Ward Jennings moved to approve the new lease with Crown Castle. Discussion followed wherein John Pawloski, Sr. expressed concerns about granting the easement to the tower from University Dr. and the possible future location of a new cell phone tower site. While the Directors concurred there were unanswered questions, those same questions were unanswered in the existing lease with Crown Castle. Based on a risk-reward analysis, the Directors voted unanimously to approve the motion.

Revise Prior Motion and Adjust Legal Budget Item: Ward Jennings moved the Directors amend their April 12, 2016, motion to authorize up to \$1,050 to retain the law firm of Smith Paknejad to review the cell tower lease. The revised motion is to authorize the legal budget to be increased by \$90.20 from \$1,000 to \$1,090.20, to increase the authorized amount to pay the full amount of the invoice from \$1,050 to \$1,090.20, and change the name of the law firm to accurately show the correct name, Provident Law. Motion carried unanimously.

New Business:

Dreamland Villa Community Club, Inc. Office Technology Upgrades: The Directors discussed the problem of updating the office computers from Windows Operating System 7 to Windows 10. PROMAS, our accounting software, is not compatible with Windows 10. Therefore, the Windows 10 upgrade has been delayed awaiting PROMAS's changes/upgrades. The office computers have been upgraded to Office Suites Products 365, Version 2016.

Telephone System: The current AT&T system is obsolete, does not have a working voicemail and has no service support to fix the current problems. Janet Peterson moved to accept Dewitt Communications LLC's proposal to replace the current telephone system with a new system handling voicemail on four incoming lines and each telephone having a display, at a cost of \$1,087.00. Motion carried unanimously.

Community Open Forum: Janet Peterson moved to hold two Community Forums at Farnsworth Hall on Monday, October 10, 2016. The first shall be at 9:00 a.m. exclusively for members of DVCC. A second meeting shall be held at 7:00 p.m. and shall be open to all residents of DVCC, both non-members and members. An attempt will be made to

find a non-director moderator to conduct the meetings. Discussion: The purpose of the meetings is to provide DVCC residents an opportunity to ask their questions and express their opinions. The moderator shall attempt to facilitate the meetings with participant decorum. The motion carried unanimously.

Study Session and Board Meeting Procedural Changes: The Directors discussed the importance of devoting the October Study Session and Board meeting exclusively to issues related to the 2017 membership drive. The Directors also discussed audience comments made at the May 10, 2016, Board meeting related to the unanimous 10 Director approving motion made at the May 12, 2015, meeting authorizing outsourcing of pool and spa daily/weekly cleaning and maintenance. The decision to outsource was made over a year ago and has saved DVCC approximately \$1,800 a month since being implemented. This represents a substantial cost savings over the former method of pool and spa cleaning and maintenance.

"Dreamland On The Go," a Travel Proposal: Pat Clark moved to accept the proposal for "Dreamland On The Go" submitted by Kathie Chismar. The Motion carried unanimously with enthusiasm. A copy of the entire proposal may be found at the end of the June 7, 2016, Board Meeting minutes posted on the Dreamland Villa website's digital library.

Access Program Development: Project has experienced delays. A change in programmer may be necessary. The volunteer project coordinator may be recommending a change in the programmer in the near future.

Single Fee per Household: Carylan McLean requested that a discussion of a single fee club membership per household, in lieu of per person membership, be tabled.

Attorney Review of DVCC's Status to Enforce 55+ Age-Restrictions: The attorney retained to review DVCC's status to enforce the 55+ age-restriction administrative requirements is now awaiting Maricopa County's response to provide a copy of the actual ordinance that created Dreamland Villa as a 55+ age-restricted Subdivision. The Directors are waiting for a response from the law firm regarding the cost of services billed to date. Directors need to determine if the cost of work performed is within the approved budgeted costs.
