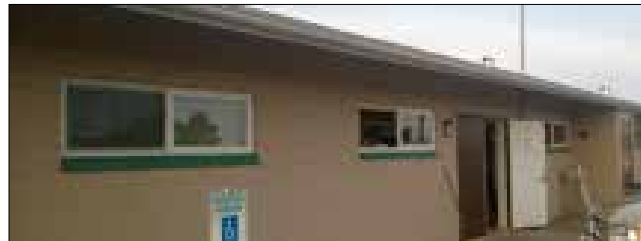

Help Services will be closed on Saturdays starting April 1, 2019 mainly due to the lack of volunteers. Our normal weekly hours remain the same, 9 to noon, Monday through Friday. Blood pressure will remain the same, always on Mondays; by the way they are doing a magnificent exemplary job, stop by and say, "Hi!" to a great bunch of folks that are there to help!

We have a new Board of Directors as follows: President of Help Services, Patty Thorpe; Vice President, Joanna Padilla; Secretary, Kriss Miles; Assistant Secretary, Betty Maynard; Treasure Charles Dubbs; Assistant Treasure, Larry Scheider and Lucile Kraiss as a new board member. What a great team to start our new year at Help Services!

I have some alarming news that I just found out about; we only have 47 monitors, some warehouse folks and some desk duty folks. This may not alarm you, but we could sure use some more help. If you have time to spare, please volunteer.

I have put together a longer equipment list this month. It may be helpful to folks that are wondering what is available at Help Services and new residence of Dreamland Villa and Velda Rose Estates.

We provide the sick, injured and convalescing residents of Dreamland Villa and Velda Rose Estates with sickroom and other health care equipment on a loaned, free basis.

Here is a long list of things that we can loan out: hospital beds, commodes, toilet risers (with and without hand rails), knee-walkers that fold, canes of all different kinds (some quads, some folding, etc.), crutches, C- walkers, wheel chairs, beds, long handle gabbers, socks adds, transfer boards, dry flotation cushions, bath tub rails, humidifiers, vaporizer, back & leg massager, slings, over the door traction sets, leg weights, sitz bath, soft donut seat, foot massager, wheelchair cushions, whirlpool hot spa, exercises cycle, baby beds, playpens, strollers, booster seats, highchairs, pulls toys, etc. I told you it would be longer! By the way, no doctor's prescription needed to borrow a stationary bike.

Please remember, Help Services is financed solely by your donations and, as always, tax deductible. Our normal hours starting April 1 2019 will be, nine AM to noon Monday through Friday. Check us out at our web page www.HelpServicesInc.org.

Call to Order: 6:38 pm following the Special Board Meeting by Johna Sharp, President

Roll Call: Kathie Chismar, Secretary. Present were Kathie Wissinger, Larry Thoma, Earl Munday, Johna Sharp, Dan Hampton, Aggie Forsyth and Kathie Chismar. A quorum was present.

General Announcements: New residents Orientation – April 6th at 10am Read Hall, last one until October. Check your calendar for future dates. Spring Fling Event - April 6th, 11:30 at Farnsworth Bandshell, Pancake Breakfast April 20th – Open to all, cost is \$5.

Parliamentarian Presentation: A presentation was held for the Directors on March 26th and presented by Vivian Vincent, District 8 Director of the National Association of Parliamentarians.

Terms of Directors: After reviewing the By-Laws with the Policies and Procedures Committee on newly elected director terms, it has been determined that of the three new directors, Larry Thomas's term will be for two years since he received the least number of votes and since Kathie Chismar still currently holds a three-year term. Earl Munday and Dan Hampton will have three-year terms. A revision to the February 13, 2019 Meeting Minutes will be prepared and the P&P Committee will be looking at clarifying the By-Law language if needed.

Old Business:

Security Cameras: Larry Thoma, Building and Grounds Committee Chair, led a discussion concerning security cameras. He estimates the cost for seven cameras, a monitor and cable would be approximately \$1100. He recommended running new cable with one camera and one monitor to try out the system before purchasing additional cameras.

Strategic Planning: Terri Tiehan, Strategic Planning Committee Chair, presented a report from the meeting that was held on March 28. She will collect data to begin the process to formulate a plan and put an article in the Citizen to gather ideas from our members.

New Business:

Policy and Procedure Changes: Earl Munday, P&P Committee Chair, discussed the changes proposed to Uniform Personnel Policy, Compensation #104 and Administrative Policy and Procedure, Purchasing. The changes are on file in the office.

The committee would like to delete the Administrative Policy and Procedure regarding Accounting as this should be defined in Office Procedures rather than Administrative Policies and Procedures. Jack presented a report to replace the outdated PROMAS system with QuickBooks. He would like to implement the new system by the end of the month and run both systems until the system is running smoothly.

Meeting Recordings: It was advised that the Parliamentarian recommended that we discontinue video recording the meetings. There are not that many views on the website.

Dreamland 60th Anniversary: Johna discussed formation of an Ad Hoc Committee to begin planning for DVRC's 60th anniversary in 2021. Information to be posted on the Website and in the Citizen.

Adjournment: The meeting was adjourned at 8:07pm.

Open Forum: Cliff Gagnon discussed the suspension of all Maricopa Posse by the Maricopa Sheriff's office. Three members of our Posse are currently working to meet the requirements set by the county.

Marantha Church Contract: A motion was made that the Board accept the new three-year contract with the Marantha Church. The motion was seconded. The motion was rescinded after debate.

New Business:

Policy and Procedure Changes: A motion was made to approve the Amendments to Personnel Policy and Procedure #104 Time Cards as discussed at the last Study Session regarding Lunch periods. The motion was seconded and passed unanimously.

A motion was made to approve the Amendments to the Purchasing Policy and Procedure as discussed at the last Study Session regarding raising the purchasing dollar amount limitations and clarifying the signatures required. The motion was seconded and passed unanimously.

A motion was made to approve the Deletion of the Accounting Policy and Procedure as discussed at the last Study Session. The motion was seconded. A motion to amend was made and seconded. The motion to approve Deletion of the Accounting Policy and Procedure as discussed at the last Study Session as it will be incorporated as an office procedure was passed with 6 in favor and 1 abstention.

Meeting Recordings: A motion was made that the Board of Directors discontinue videotaping all meetings, including the Board Study Sessions, the regular Board Meetings, General Membership Meetings and any Special Meetings. The motion was seconded and passed with 6 in favor and 1 opposed.

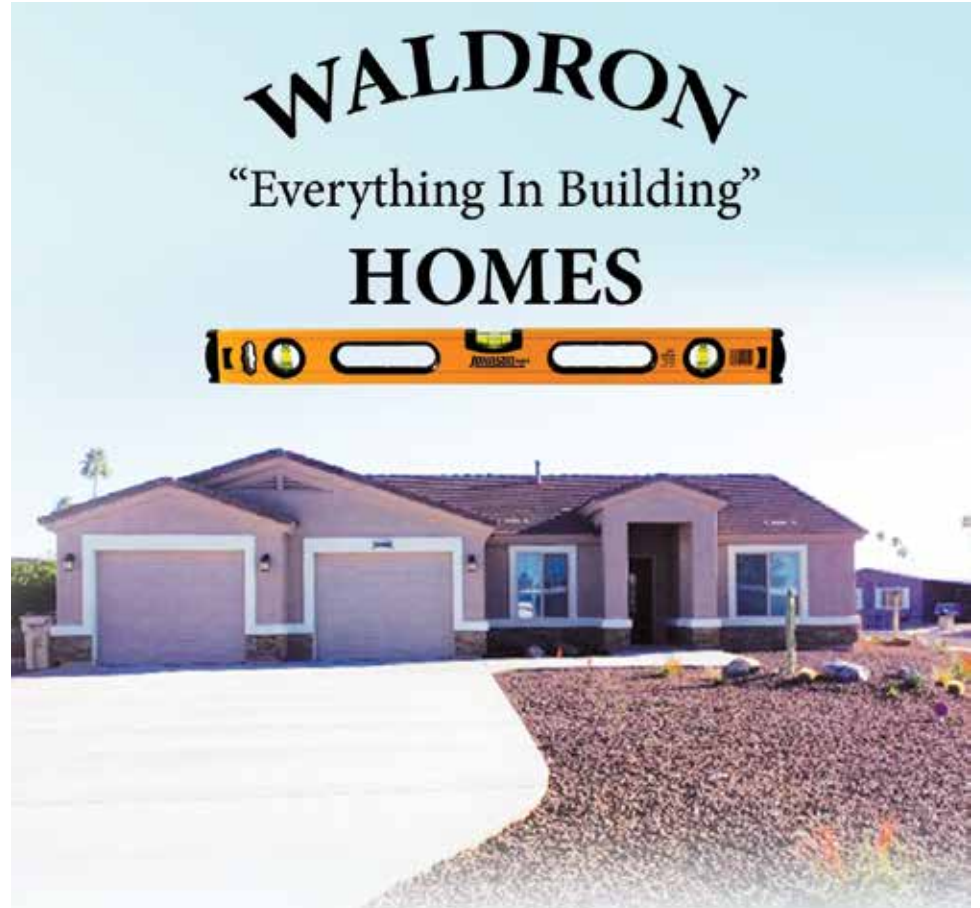

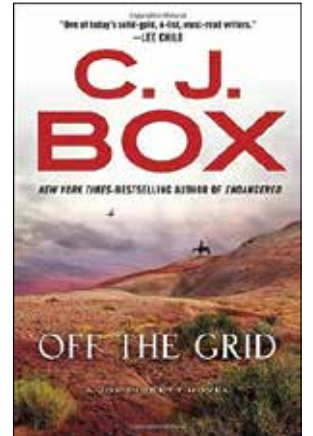
Off The Grid by C.J. Box

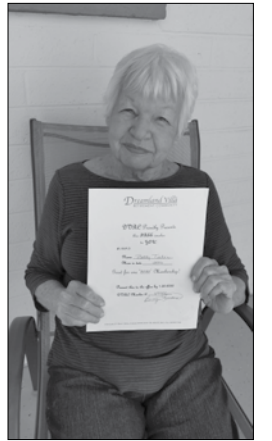
